SPECIAL AND CHARTER TRAIN COACHING STOCK

A) VINTAGE TRAINS

Mark 2 TSO 5177 has now been painted in Chocolate and Cream livery and returned to operational mainline use. This is the fourth Mark 2 TSO to have been returned to operational mainline use, the others being 5157, 5191 and 5198.

Railfilms Ltd owned GWR Saloon 9004 and LMS Club Car (adapted from Mark 1 TSO 5067) are currently seeing use in trains operated by Vintage Trains and are temporarily based at Tyseley for this purpose.

B) RAIL CHARTER SERVICES

Mark 1 BSK generator 35469 has now been painted in Maroon livery, it had previously carried Carmine & Cream livery.

C) WEST COAST RAILWAY COMPANY

Two further Mark 2 Carriages, TSOs 5453 and 5487, have been hired to Valley Lines. This now means eight of the companies Mark 2s, TSOs 5453, 5463, 5478, 5487, 5491, 5569 and BSOs 9440 and 9448, see regular use on peak hour Rhymney – Cardiff and return trains, in addition they are used for other services as required.

The carriages in use on West Highland steam services this summer are Mark 1s RMB 1860, FO 3130 (99128), TSOs 4931 (99329), 4940, 4954 (99326), 4958, BCK 21256 (99304), BSK 35459 (99723). Seven of these carriages were used in 1999 and 2000, the addition being BSK 35459, a second Brake vehicle being required this year in order to operate two trains simultaneously at the end of the season.

D) RIVIERA TRAINS

Two Mark 2 TSOs, 5276 and 5322, have been acquired from HSBC Rail, they have both been overhauled and painted into the Oxford Blue & Cream livery. They have now entered service with the company.

Previously Stored Mark 2 FO 3223 has now been painted into the Oxford Blue & Cream livery and returned to service. It is now named 'DIAMOND'. Similarly the former Mark 2 Royal Household Couchette 17105 has returned to service following a repaint in all over Oxford Blue.

Other repaints of operational carriages have been Mark 1 RB 1683 into all over Oxford Blue, previously Oxford Blue and Cream, and Mark 2 FO 3240 into Oxford Blue & Cream, previously Chocolate & Cream. In addition this latter carriage is now named 'SAPPHIRE' having previously being named 'PENDENNIS'.

4) News of Mainline Operations

a) Railfilms Ltd, Crewe

The correct description of the livery now carried by Mark 2 Power/Kitchen Car 35511 and Mark 1 BG 81025 is British Racing Green with Gold Lining. This livery has now been applied to Mark 2 FOs 3231 and 3246 that are currently nearing the end of an overhaul at the Crewe premises of L&NWR. This overhaul has included the fitting of down train through mains electrics so as to be operational with the Power/Kitchen Car. Seating capacity is also being reduced so as to add a degree of spaciousness for VIP Charter work.

GWR Saloon 9004 and LMS Club Car (adapted from Mark 1 TSO 5067) are currently located at Tyseley Locomotive Works (former Birmingham Railway Museum) and are seeing use in trains operated by Vintage Trains.

b) Mid-Hants Railway

A further two Mark 2 carriages have been overhauled and are now available for main line use. These are BSO 9392 and FK 13474, both carry Southern Region Green livery.

c) Venice-Simplon Orient Express

Stored Mark 1 BSK 35207 has been disposed of to the East Somerset Railway.
