### SPECIAL AND CHARTER TRAIN COACHING STOCK

#### 1) English, Welsh and Scottish Railway

Mark 1 RB 1653, Mark 2s TSO 5616, FKs 13604 & 13607, BFKs 17141, 17165 & 17172 and Mark 3 SLE 10730 have been disposed of for scrap.

Mark 1 TSO 4977 has been disposed of and is now located at the Watercress Line.

Mark 2 BSO 9531 has been acquired from Riviera Trains. This carriage has been painted Maroon and is now in service based at Old Oak Common. Also now painted Maroon and in service at Old Oak Common are Mark 2s FO 3279, 3331, 3358, 3388, 3414 & 3424 and TSOs 5657, 5954 & 5959.

Mark 1 TSO 4999 that was stored at Crewe Diesel has been moved to Old Oak Common for further storage. Also now stored at Old Oak Common are Mark 1s RMB 1832, FOs 3100, 3127 & 3133, TSOs 4925, 4946, 4956, 4991, 4996, 5005, 5007, 5027 & 5037 and BCK 21245 that have now been taken out of service.
