#### 4) Corrections to 'Preserved Coaching Stock of British Railways - Part one'

It has now been established that all Corridor Seconds of lot 30349 were built with BR Mk I Madison (BR II) bogies. Thus the following changes should be made:-

- In the section on **Bogies** the narrative regarding **BR Mk I Madison** (**BR II**) Page 9 should have the word 'certain' deleted from the second sentence.
- Page 16 Delete the following section: - 7. BR Mark I replaced with BR Mark I Madison
- Page 42 In the details for **Lot No.** 30349 **Bogies** should be BR II and the statements '25346/47/55/62/64/66/85 rebogied with BR II bogies' and '25307/12 preserved with BR II bogies' should be deleted. It should be noted that the later statement was altered as a result of information contained in Ammendment Sheet Number Two which was subsequently found to be incorrect.
