SPECIAL AND CHARTER TRAIN COACHING STOCK

1) Riveria Trains

Mark 2 FOs 3181 and 3188 are no longer in the operational fleet and are now stored at Crewe Diesel Depot.

2) English, Welsh and Scottish Railway

Mark 2 TSO 6124 and BSO 9524 have received collision damage whilst in use with the Valley Lines Unit of Arriva Trains Wales. Both have been put into storage at Toton.

Six Mark 2s, FOs 3292, 3318, 3368 & TSOs 6036, 6139, 6152 have been leased from HSBC Rail (UK). These six carriages are currently stored at Toton were they are being painted Maroon.

3) Vintage Train

In Amendment Sheet 76 it was recorded that Pullman Cars Parlour Second with Kitchen 'CAR No.335' and Bar Car 'The HADRIAN BAR' had been acquired from the West Coast Railway Company. This should have read Parlour Second with Kitchen 'CAR No.335' and 'CAR No.353'.

4) West Coast Railway Company

In Amendment Sheet 76 it was stated that Mark 1 Generator Van 6312 had been painted into Maroon livery. This information was incorrect and this carriage remains in Pullman Car Umber & Cream livery.

Mark 1 SK25756(99721) has been returned to service has been one of the carriages used for the summer 2005 season of York-Scarborough trains using locomotive 4472 'FLYING SCOTSMAN'. The full fleet of Mark 1 carriages used being RMB 1861, FOs 3113(99125), 3128(99371), TSOs 4912(99318), 4973, 5033(99328), 5044(99327), 25806(99722), SKs 25756(99721), 25767(99710) and BSK 35459(99723).

Stored Mark 1 RB 1684 and Mark 2 TSOs 5645, 5709 and 5712 have been scrapped.

Mark 2 TSOs 5600(99322), 5704(99323), 5714 (99324), 5727(99325) and 5756 have been taken out of the operational fleet and are now stored at Carnforth pending further use.
